We are also looking for individuals who can contribute the following **skills** to the board: **Strategic planning, financial management, revenue generation, research, human resources, legal/risk management, technology.**

The third part of the balance is **geographical representation**. Therefore, this year we are encouraging nominations from the following provinces and territories: **Saskatchewan, Manitoba, New Brunswick, Nova Scotia, Newfoundland and Labrador, Yukon, Northwest Territories, Nunavut, and Alberta.**
